Busy Bees Garden Club Rules:

Please discuss these rules with your Busy Bee gardener in a developmentally appropriate way to help us have a fun and safe time at the garden.

1. All children must be accompanied by a responsible caregiver at all times.
2. Busy Bees participants and their guardians must stay within designated areas.
3. Do not enter any garden plots unless invited by the plot gardener.
4. Each child is responsible for their individual plants within the garden. Please do not touch other children's plants.
5. Put all equipment away.
6. Turn off all water spigots.
7. Help keep the garden clean. Pick up any litter and dispose of it.
8. Pull weeds in your plot as needed.
9. Plants should not be covering pathways. Trellises are provided, but plants grow. If needed, plants should be pruned or tied up to avoid obstructing pathways.
10. Children should not go in either shed without an adult present.

There is a \$10 fee per child or \$15 per family. Funds are used to replenish the soil in the raised beds, repair the beds, purchase garden tools, seeds and seedlings for the students, and supplies for the learning activities. If this is a financial hardship, please let us know.

Certification: Signing of this agreement constitutes acceptance of the terms and conditions outlined by RVACG. The gardener agrees to allow RVACG to use any photographs, interview, videotapes, film, other visual or auditory recordings, or any other medium of the gardener that the RVACG may create in connection with the gardener's participation in the garden, including on the internet. Liability Waiver, Release, Indemnification and Acknowledgements: The gardener understands that participation in the garden has a risk of injury, damage to personal property or death. The gardener agrees to assume the risk of harm even if the potential harm is caused by someone else. The gardener also agrees to waive any right to sue or attempt to collect money from the landowner, sponsor, board members, employees, volunteers or anyone acting on their behalf for any losses or damages resulting from death, injury or property damage to the gardener, anyone else, or any property, that occurs while the gardener is in the garden. The gardener gives up any right to sue or otherwise attempt to collect money from the RVACG or the Village of Spring Green arising out of any first aid, treatment or medical service, including the lack of such or timing of such, given in connection with participation in the garden. The gardener is not covered by or eligible for any insurance, health care, workers' compensation or any other benefits maintained by the aforementioned parties. The gardener is responsible for any damages or losses suffered by the sponsor or landowner that are caused by the gardener.
